Manufacturers and Traders Trust Company is successor to The Chase Manhattan Bank as the indenture trustee (the “Trustee”) under a Trust Indenture dated as of August 1, 2000 (the “Indenture”) between Dallas-Fort Worth International Airport Facility Improvement Corporation and the Trustee, pursuant to which the Bonds were issued in the original principal amount of \$30,000,000.

Unless otherwise noted, capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Indenture.

Summary Information Regarding Chapter 11 Bankruptcy

Prior notices given by the Trustee informed you of the Chapter 11 Bankruptcy (the “Chapter 11 Cases”) of American Airlines, Inc., AMR Corporation and eighteen (18) affiliated entities (the “Debtors”), Case No. 11-15463 (SHL), in the United States Bankruptcy Court for the Southern District of New York (the “Bankruptcy Court”) and certain Events of Default resulting from the filing of the Chapter 11 Cases. On October 22, 2013, the Bankruptcy Court approved the Debtors’ Fourth Amended Joint Chapter 11 Plan (the “Plan”), which was premised on a merger agreement between the Debtors and U.S. Airways Group, Inc.

A copy of the Plan, as well as copies of the Trustee’s prior notices, is available through a special link on the website of the Trustee’s counsel: www.drinkerbiddle.com/americanairlinesbondholders. Pursuant to the Plan, the Bonds have been cancelled.

Plan Effective Date and Distribution Record Date

All capitalized terms used in this section shall have the meanings ascribed to them in the Plan.



The Effective Date of the Plan occurred on December 9, 2013, which was also the Distribution Record Date. Thereafter, the Debtors made distributions to holders of Allowed Claims as provided in the Plan.

Plan Distributions Complete

The Trustee hereby informs you that as of April 8, 2014, all distributions under the Plan have been made and that no further distributions will be made under the Plan. Pursuant to the Plan the securities are canceled, and the Trustee instructs The Depository Trust Company to remove the participant positions.
