STIPULATION AND [PROPOSED] ORDER

WHEREAS, action No. 14 Civ. 7091 (SAS) (the "MeehanCombs Action") was commenced by filing a Summons and Complaint on September 3, 2014; and

WHEREAS, action No. 14 Civ. 07973 (SAS) (the "Danner Action") was commenced by filing a Summons and Complaint on October 2, 2014, and on October 14, 2014 was accepted as related to the MeehanCombs Action and was assigned to this Court; and

WHEREAS, the parties have agreed to a coordinated schedule for defendants to answer or move in response to the complaints in the MeehanCombs Action and the Danner Action (together, the "Complaints"), and for briefing any motions to dismiss; and


WHEREAS, there has been one previous extension of defendants' time to answer in the MeehanCombs Action, and no previous adjournments or extensions of time in the Danner Action;

NOW, THEREFORE, IT IS STIPULATED AND AGREED, by and between the parties, through their respective counsel, subject to approval of the Court, that:

1. Defendants shall answer or move in response to the Complaints on or before November 12, 2014.
2. In the event that defendants elect to move to dismiss the Complaints, defendants shall serve the letter required by the Court's Individual Rule IV(B) on or before October 29, 2014, and plaintiffs shall serve their responsive letters on or before November 7, 2014.
3. In the event that defendants move to dismiss the Complaints, plaintiffs' opposition papers shall be filed on or before December 3, 2014; and defendants' reply papers shall be filed on or before December 19, 2014.


